

EY-EK Inbound Tourism

<u>Purpose</u>

This program aims to encourage tourism in the UAE and make it easier for visitors to explore Abu Dhabi, Dubai, and other emirates.

Terms & Conditions

- This is a pure interline cooperation, much like any other interline partnership, with specific features only relevant to this program.
- This program can be sold on EY or EK ticket stock.

Fares & Surcharges

- The product is available for sale through EY or EK Contact Centre and Travel Agencies. It is currently being developed on online channels.
- Point-to-point sector fares of EY and EK to be combined on half RT open jaw basis (open jaw may occur only in the UAE).
- Applicable only on published fares.
- One-way fare combinations and unpublished fares (including corporate fares) are not allowed.
- Mandatory combination: one Party in inbound direction, the other Party in outbound direction (e.g. MUC-EK-DXB//AUH-EY-MUC or MUC-EY-AUH//DXB-EK-MUC); participation of both carriers in RT itinerary is a must.
- Returning to the point of origin is mandatory on these tickets; through itineraries (e.g. LHR-EY-AUH//DXB-EK-PEK) cannot be used.
- Fares dedicated to the project will be a replica of the published structure with a specific fare basis.
 - EY fare basis code with 'Q' in the 8th position, e.g., ELN28H2Q
 - EK fare basis with 'Y' in the 4th position, e.g., KLEYSAT1
- Mixed cabin itineraries are allowed.
- YQ/YR and Q surcharges as filed in ATPCO and applicable on a per component basis.
- Changes/reissues:
 - Most restrictive fare condition applies.
 - Changes can be done through the booking source.
- Cancellations/refunds:
 - Most restrictive fare condition applies.
 - Cancellations can be done manually through the booking source.

<u>SSR Management</u>

- Special Service Request (SSR) wheelchair or meals can be requested through the booking. All other SSRs (e.g. UMNR, PETC, MEDA) on EY sector can be booked only if the ticket is issued on EY stock.
- Chauffeur service permitted in accordance with general policy



<u>Routings</u>

- A limited number of routes and flights are included.
- The program will start with routes commencing in Europe and China to the UAE, on selected flights only.
 - From China, only Beijing is included.
 - From Europe, the program can be booked out of Germany (MUC & DUS), Russia (SVO & LED), LHR, GVA, VIE, BRU and CPH.

Loyalty Programs

• No earn and burn cooperation between loyalty programs is included. EY Guest benefits are only available on EY segments.

DCS (Airport Check-in)

- EY guests (holders of EY ticket) can buy excess baggage at Emirates DCS counter at the airport; however, chargeable seats, upgrades, or priority access are not available on Emirates flights.
- EK guests (holders of EK ticket) can book any seat of choice (including chargeable seats), buy excess baggage, upgrade, and priority access at the Etihad check-in at the airport.

<u>FAOs</u>

Q: Can a guest holding EK ticket purchase Excess Baggage (EB) and/or preferred seat on EY sector through EY website?

A: Yes, a guest holding EK ticket purchase Excess Baggage (EB) and/or preferred seat on EY sector through EY website or EY Contact Centre.

Q: Can a guest holding EY ticket purchase ancillaries on EK sector through EK website? **A:** Yes, the guest can purchase any ancillary on EK sector through EK website or EK Contact Centre or at the airport.

Q: Can a guest holding EY ticket purchase ancillaries on EY sector through EY website? **A:** Yes, the guest can purchase excess baggage, preferred seat, and priority access on EY sector through EY website and/or the EY Contact Centre.

Q: Can a guest make changes to EY/EK sectors via EY/EK website?A: No, changes can be made only through the original booking channel or respective airline Contact Centre.

Q: Can a guest cancel booking of EY/EK sectors via EY/EK website? **A:** No, cancellation can be made only through the original booking channel. Refund must be performed manually. EY Contact Centre agents can queue the booking to EY Refunds team for processing.

Q: Can existing EY+EY tickets be reissued to have EY+EK or vice versa? **A:** No.

Q: How does baggage allowance apply? **A:** Baggage allowance applies as per the fare/brand purchased.
